### About the ENERGYWISE™ Warm Up New Zealand: Heat Smart Programme

EECA subsidies are available for a homeowner's dwelling, and/or for each of the properties a landlord may have rented out as domestic dwellings. The property must have been built prior to 1 January 2000.

The subsidy will cover:

**33% of the total cost of installing insulation, up to \$1300 inc GST.**

If you are the home owner and hold a current Community Services Card (CSC), or you are a landlord and your tenant holds a CSC, you may be eligible for a subsidy of 60% inc GST of the total cost of installing insulation.

**\$500 inc GST towards the cost of a clean heating source, such as an approved heat pump.**

If you are the home owner and hold a CSC, you may be eligible for \$1200 inc GST towards a clean heating source.
